



3. Mrs. Asha Mathew (Manager-Infection Control)


1. **Opening of the meeting:** Meeting was called to order by the Chairman at 12.30 pm who welcomed the members.
2. **Minutes of the previous meeting:** The minutes of the previous meeting was read and passed unanimously by the committee.
3. **Points out of the previous minutes:** Nil
4. **Points from the Chair:**

- a. Received the PCB Award for outstanding contribution and commitment to environmental protection and sustainable practices. Secured second prize in the category: *Private Hospitals with 250 to 500 beds*.
